

ARTIST/POET RELEASE FORM

Artist/Poet Agreement

The Artist/Poet identified below (“Artist/Poet”) seeks to display artwork/writings and/or related materials that he/she has authored or created for posting on the WIRED Foundation’s web site. The WIRED Foundation reserves the sole right to select the writings/artwork submitted for posting on the Artist/Poet page of the web site. This submission shall be made without any compensation due to the undersigned, undersigned parent or guardian.

The Artist/Poet shall affirm and represent that he/she is the sole, legal owner of all rights, title and interest in all artwork and writings and has the sole right and authority to enter into this agreement and grants the rights outlined in this agreement.

The Artist/Poet hereby releases, discharges and agrees to hold harmless the WIRED Foundation and all of its legal representatives and assignees, and all persons acting under its permission or authority or those for whom it is acting from any liability that may arise by virtue of blurring, distortion, alteration, optical illusion, faulty reproduction or use in a composite form, whether intentional or otherwise that may occur or be produced in the posting of the artwork/images or writings or in any subsequent processing. Further, the undersigned or undersigned parent or guardian knowingly, freely and voluntarily releases and discharges the WIRED Foundation and its representatives of any and all liability, claims, judgements, demands, costs, causes of legal action, including without limitation rights of privacy and publicity and damages of any kind for any personal injury, losses or damages, known or unknown, to the undersigned and the undersigned’s minor child caused by or arising out of the WIRED Foundation use of artwork/writings.

Should the undersigned (Artist/Poet), undersigned parent or guardian be subjected to any ridicule, embarrassment, scandal, indignity, reproach or disparagement, after the artwork/writing is displayed on the web site, he/she shall hereby release and hold harmless the WIRED Foundation and its representatives from any cause of action, liability, claims, judgements, personal injury, losses, damages of any kind known or unknown.

The Artist/Poet shall have the right to have their name/identity used in conjunction with the artwork/writing. The Artist/Poet represents that he/she is the sole legal owner of right, title and interest in the artwork/writing including intellectual property interests such as trademarks and has the sole and exclusive copyright in all artwork and has the full right and authority to enter into this agreement and grants the rights granted in this agreement.

The Artist/Poet agrees that the WIRED Foundation and its representatives have the sole discretion to display and remove the Artwork/Writing at anytime.
